I, Leesa Manion, Prosecuting Attorney for King County in the name and by the authority of the State of Washington, do accuse HALEY ANN ROY, AND MICHAEL JOSEPH LEMAY of the following crime[s], which are based on the same conduct or a series of acts connected together or constituting parts of a common scheme or plan: **Residential Burglary, Residential Burglary, Theft Of Motor Vehicle, Theft In The Third Degree, Theft In The Third Degree, Taking Motor Vehicle Without Permission in the Second Degree, Vehicle Prowl In The Second Degree**, committed as follows:

**Count 1: Residential Burglary**

That the defendants HALEY ANN ROY AND MICHAEL JOSEPH LEMAY and each of them in King County, Washington, on or about January 12, 2026, did enter and remain unlawfully in the dwelling of Emily Wakefield, located at 34426 SE Hearing St, Snoqualmie, in said county and state, with intent to commit a crime against a person or property therein;

Contrary to RCW 9A.52.025, and against the peace and dignity of the State of Washington.

**Count 2: Residential Burglary**

That the defendants HALEY ANN ROY AND MICHAEL JOSEPH LEMAY and each of them in King County, Washington, on or about January 12, 2026, did enter and remain unlawfully in the dwelling of Emily Wakefield, located at 34426 SE Hearing St, Snoqualmie, in said county and state, with intent to commit a crime against a person or property therein;

3           **Count 3: Theft Of Motor Vehicle**

4           That the defendant HALEY ANN ROY AND MICHAEL JOSEPH LEMAY in King  
5 County, Washington, on or about January 12, 2026, with intent to deprive another of a motor  
6 vehicle, did wrongfully obtain such property, an Audi Q5, belonging to Emily Wakefield;

7           Contrary to RCW 9A.56.065 and 9A.56.020(1), and against the peace and dignity of the  
8 State of Washington.

9           **Count 4: Theft In The Third Degree**

10          That the defendant HALEY ANN ROY AND MICHAEL JOSEPH LEMAY in King  
11 County, Washington, on or about January 12, 2026, with intent to deprive another of property,  
12 to-wit: personal items, did wrongfully obtain such property belonging to Emily Wakefield;

13          Contrary to RCW 9A.56.050 and 9A.56.020(1)(a), and against the peace and dignity of  
14 the State of Washington.

15          **Count 5: Theft In The Third Degree**

16          That the defendants HALEY ANN ROY AND MICHAEL JOSEPH LEMAY and each of  
17 them in King County, Washington, on or about January 12, 2026, with intent to deprive another  
18 of property, to-wit: packages, did wrongfully obtain such property belonging to Swapna  
19 Vellanki;

20          Contrary to RCW 9A.56.050 and 9A.56.020(1)(a), and against the peace and dignity of  
21 the State of Washington.

22          **Count 6: Taking Motor Vehicle Without Permission in the Second Degree**

23          That the defendant MICHAEL JOSEPH LEMAY in King County, Washington, on or  
24 about January 12, 2026, intentionally and without the permission of Erin Brunette, the owner or  
person entitled to possession thereof, did take and drive away an automobile or motor vehicle,  
to-wit: a Dodge Challenger, and with knowledge that said vehicle had been unlawfully taken did  
voluntarily ride in or upon said automobile or motor vehicle;

25          Contrary to RCW 9A.56.075, and against the peace and dignity of the State of  
26 Washington.

27          **Count 7: Vehicle Prowl In The Second Degree**

That the defendant MICHAEL JOSEPH LEMAY in King County, Washington, on or about January 12, 2026, did unlawfully enter in a vehicle, to-wit: a Toyota 4Runner belonging to Chase Wakefield, with intent to commit the crime of theft against property therein;

Contrary to RCW 9A.52.100(1), (2), and against the peace and dignity of the State of Washington.





2 The footage shows a female suspect exit the passenger seat of a white suspect vehicle,  
3 enter and start the victim's Audi Q5, back the Audi Q5 out of the victim's garage, and  
4 then drive away followed immediately by the white suspect vehicle.

2. I further declare that a review of the Abstract of Driving Record for the defendant, Michael Joseph Lemay, from the Judicial Access Browser System (JABS) indicates that a revocation occurred due to "accumulation of convictions or points" with a start date of "2/25/2013" and a currently listed end date of "2/25/2099"; the requirements for reinstatement list "Habitual Traffic Offender reinstatement hearing required"; the defendant's current driver license status is "Revoked 1st Degree."
3. According to the report written by Officer Westman of the Snoqualmie Police Department, the owner of the Dodge Challenger is Erin Brunette.
4. According to the report written by Officer Hoyla of the Snoqualmie Police Department under related report number 26S-0188, the owner of the packages taken from the residence nearby Emily Wakefield's home is Swapna Vellanki.

**Currently Charged Offense:** On 1/12/26, Snoqualmie police dispatched to a residence at 34426 SE Hearing St in Snoqualmie, belonging to Emily Wakefield. Surveillance footage shows that at about 0556 hours, defendants Roy and Lemay arrived in a Dodge Challenger outside the garage which they opened with a garage opener that defendant Lemay later admitted to taking from Emily's husband's Toyota 4Runner which was parked outside the residence. Defendant Roy, seen wearing a red sweatshirt took a backpack along with other items from the garage while

2 defendant Lemay, who wore a green sweatshirt, took papers from Wakefield's Audi Q5 that was  
3 in the garage. Both defendants then returned to the Dodge and left.

4 The defendants then returned to Wakefield's garage in the Dodge, driven by defendant  
5 Lemay. Defendant Roy re-entered the garage, got into the driver's seat of the Audi and then  
6 drove away in it. The defendants also took packages off a porch on Frontier Ave, less than a  
7 quarter of a mile away from the Wakefield residence.

8 Later in the evening on 1/12/26, law enforcement saw the Dodge Challenger along with the  
9 defendants at a Safeway in Snoqualmie. When police initially contacted them and told them they  
10 matched descriptions of people involved in a burglary, defendant Lemay started the car and  
11 reached for the gear shifter, but stopped once police told him there was a spike strip in front of  
12 his tire.

13 On running the VIN to the Dodge, it returned as stolen out of Seattle PD, reported on  
14 1/3/26. There was also a California plate on the Dodge that returned as stolen. Police also  
15 observed there was a piece of paper with another set of numbers that appeared to nearly be  
16 obscuring the VIN. Items in the Dodge appeared to be consistent with what was reported as  
17 taken in the residential burglary from the Wakefield residence.

18 Post-Miranda, Lemay said he had a mechanic friend who let him borrow the Challenger  
19 as he was working on the car for a customer and said he'd had the car for 3-4 days. He then  
20 admitted to taking packages from another residence and that he had prowled at least one vehicle,  
21 and thought he did take a garage opener. Roy said Lemay had bought the Challenger from a  
22 friend and she and Lemay had been in the car for about a week, and admitted to being at the  
23 Wakefield residence twice and taking the Audi.

4       Pursuant to CrR 2.2(b)(2)(i) and (ii), the State requests bail set in the amount of **\$5,000.00** set by the court at first appearance as the defendant is not likely to appear in response to a summons and presents a danger to community safety. At first appearance, the State requested \$100,000 but the court only imposed \$5,000.

8       **Criminal History:** Although the defendant has no felony convictions, a diligent review of defendant's Defendant Case History on JABS and returns for defendant from NCIC revealed the defendant has the following misdemeanor and gross misdemeanor convictions: Vehicle Prowling 2 (2022x3), False Statement to Public Servant (2022), DUI (2022), Possess Stolen Property 3<sup>rd</sup> Degree (2022), Reckless Driving (2022, 2021x2), Assault 4<sup>th</sup> Degree (2020), Hit/Run Unattended Vehicle (2020), No Contact/Protection Order Violation (2018).

14       **Pending Criminal Offenses:** A diligent review of defendant's Defendant Case History on JABS revealed the defendant has the following pending criminal matters: 5A0100081 No Valid Oper License W/Out Identif, Reckless Driving (1/13/25) out of Lynnwood Municipal Court.

18       **Warrant History:** According to JABS, Washington courts have issued 22 warrants for the defendant's arrest since 2018, including one warrant that remains active at the time of this writing on her pending Lynnwood Municipal matter, issued on 8/7/25.

22       **Requested Conditions of Release:** The State requests standard conditions of release, including appearing for all required court hearings, providing updated contact information to the court, and committing no new law violations, and further that the defendant have no contact with Emily Wakefield, Chase Wakefield, Swapna Vellanki, 34426 SE Hearing St in Snoqualmie or co-defendant Michael Joseph Lemay.

2        The defendant's warrant history and active warrant demonstrate she will not voluntarily  
3 come to court. Additionally, the defendant not only accessed the victim's home once but then  
4 returned and took the victim's car. While there are no violent acts alleged in this matter,  
5 residential burglaries come with an inherent risk of violence based on the likelihood of  
6 confrontation when a defendant unlawfully enters someone's home, especially at hours when the  
7 homeowner is likely to be present. The State is also concerned for the victim's safety given the  
8 targeted and repeated contacts with the victim's home. The State's concern that she is a danger to  
9 community safety is further underscored by her multiple convictions for reckless driving, DUI,  
10 Hit and Run Unattended and that she has a pending matter for Reckless Driving. For the above  
11 reasons the State respectfully requests this Court impose \$5, 000 in bail and the State's other  
12 requested conditions of release.

13  
14 **Michael Joseph Lemay**

15        Pursuant to CrR 2.2(b)(2)(i) and (ii), the State requests bail set in the amount of **\$100,**  
16 **000.00** set by the court at first appearance as the defendant is not likely to appear in response to a  
17 summons and presents a danger to community safety.

18        **Criminal History:** A diligent review of defendant's Defendant Case History on the  
19 Washington Judicial Access Browser System (JABS) and returns for defendant from the  
20 National Crime Information Center (NCIC) revealed the defendant has the following felony  
21 convictions: Attempting to Elude Police Vehicle, Theft 2 (2018), Stolen Property Trafficking 2  
22 (2014), Take Vehicle W/O Permission 2x2 (2014), Possession Stolen Property 2 (2010),  
23 Attempted Theft of Motor Vehicle (2009).

1  
2        The defendant also has the following misdemeanor and gross misdemeanor convictions:  
3 DWLS 2<sup>nd</sup> Degree (2025, 2012, 2010x3), Obstruct Law Enforcement Officer (2023), DWLS 1<sup>st</sup>  
4 Degree (2023, 2021x2, 2016x2, 2014, 2013), Theft 3 (2021, 2020), DWLS 1<sup>st</sup> Degree amended  
5 to DWLS 3<sup>rd</sup> Degree (2021), Fail to Transfer Title within 45 Days (2021), False Statement to  
6 Public Servant (2017), Malicious Mischief 3 (2015), DWLS 1<sup>st</sup> Degree amended to DWLS 2<sup>nd</sup>  
7 Degree (2014), Reckless Driving (2014), DWLS 3<sup>rd</sup> Degree (2009), Criminal Trespass 2<sup>nd</sup>  
8 Degree (2008).

9        **Pending Criminal Offenses:** A diligent review of defendant's Defendant Case History  
10 on JABS revealed the defendant has the following pending criminal matter: 5A0955225 DWLS  
11 1<sup>st</sup> Degree (12/27/25) out of King County District Court. His ADR in JABS shows his license is  
12 revoked in the first degree.

13        **Warrant History:** According to JABS, Washington courts have issued 58 warrants for  
14 the defendant's arrest since 2008.

15        **Requested Conditions of Release:** The State requests standard conditions of release,  
16 including appearing for all required court hearings, providing updated contact information to the  
17 court, and committing no new law violations, and further that the defendant have no contact with  
18 Emily Wakefield, Chase Wakefield, Swapna Vellanki, Erin Brunette, 34426 SE Hearing St in  
19 Snoqualmie or co-defendant Haley Ann Roy.

20        The defendant has significant warrant history as well as a prior conviction for Attempting  
21 to Elude a Police Vehicle, demonstrating he will not voluntarily come to court. Additionally, the  
22 defendant tried to flee when contacted by law enforcement and only turned car he was in off  
23 when police told him there were spike strips in front of his tires. The defendant entered the

Wakefield residence along with co-defendant Roy in the early hours of the morning, creating an inherent risk for confrontation and violence and then returned to the victim's home to commit a second crime. The State is concerned for the victim's safety given the targeted and repeated contacts with the victim's home. The State is also concerned for community safety given that the defendant was driving when he is not legally permitted to as his license is currently suspended in the first degree and he has multiple convictions for DWLS 1<sup>st</sup> Degree and DWLS 2<sup>nd</sup> Degree.

For the above reasons the State respectfully requests this Court impose \$100,000 in bail and the State's other requested conditions of release.

**CERTIFICATION OF PROBABLE CAUSE**

That **Chase Smith #662** is a Sergeant with the Snoqualmie/North Bend Police Department and has reviewed the investigation conducted within the City of Snoqualmie, King County Washington. Snoqualmie Police Department Incident Number 26S-0195.

There is probable cause to believe that **Michael J. Lemay, DOB: 06-18-1989** committed the crime(s) of: **Residential Burglary, Possession of a Stolen Vehicle, Possession of Stolen Property x 2, Theft 3.**

**RCW: 9A.52.025, 9A.56.068, 9A.56.070, 9A.56.050**

This belief is predicated on the following facts and circumstances:

On 01/12/26 at about 0720 hours, Snoqualmie Police were dispatched to a cold residential burglary at 34426 SE Hearing St within the city limits of Snoqualmie (Case #26S-0183). The complainant/victim (Emily Wakefield) stated their vehicle was stolen from their garage around 0600 hours. The vehicle (WA plate #BWK2946) is a 2017 Audi Q5 SUV. At this residence there is a camera on the outside of the garage and a camera inside of the garage.

At about 0556 hours, the cameras show a white Dodge Challenger park directly in front of the garage of the residence. The two suspects (1 white male and 1 white female) enter the garage. The female is wearing a red sweatshirt, red sweats, what looks like white cat ears and tan boots with heels. The male is wearing a green sweatshirt and jeans. The female is seen stealing a backpack and other items from the garage and places them in the passenger seat of the Dodge Challenger. The male is seen stealing paperwork from inside the Audi SUV that is in the garage. The male and female then leave the residence while leaving the garage door open.

Later the male and female go back to the same residence at 34426 SE Hearing St. The challenger is seen on video stopping in front of the garage. The female exits the Dodge Challenger, reenters the garage and gets in the driver's seat of the Audi. The female then drives away in the Audi. The victim stated that the keys to the Audi were inside the vehicle.

The suspect vehicle was a white Dodge Challenger with black wheels and a black racing stripe on the hood and roof.

It was later learned that the suspects were able to open the garage door by stealing the garage door opener from the victim's husband's (Chase Wakefield) vehicle that was parked on the street in front of the residence.

Based on Police investigation the suspect prowled Chase Wakefield's 2019 Toyota 4 Runner (WA plate #CPD6274) and stole a garage door opener to gain access to the garage. The male and female entered the garage and stole items. The suspects then returned and the female reentered the garage and stole the Audi SUV (WA plate #BWK2946). The Audi was entered as stolen, and the victim completed a sign stolen form. For further facts and information refer to Officer Peter's case report.

It should be noted the suspects were also seen on other surveillance footage stealing packages (groceries) off a porch on Frontier Ave in the city of Snoqualmie (Case #26S-0188). Frontier Ave is less than a quarter mile from where the residential burglary occurred. The same female and Dodge Challenger are seen in this footage. For further facts and information refer to Officer Hoyla's case report.

On 01/12/26 at about 2143 hours, I was parked in the Snoqualmie Safeway parking lot at 34828 SE Douglas St within the city limits of Snoqualmie. I noticed a white Dodge Challenger parked a few stalls west of me. Officer Peter, who was the primary Officer on the residential burglary case, sent an email today with a photograph of the Dodge Challenger and the female suspect. The vehicle appeared to be the same vehicle from the residential burglary. I saw a white female walking towards the vehicle and a male in the driver's seat. The vehicle was not running.

I quickly looked at the photographs that Officer Peter had sent and believed the female that just entered the passenger seat of the Challenger was the same female from the residential burglary. The vehicle appeared to match the suspect vehicle as well.

I quickly exited my patrol vehicle with the terminator (portable tire deflation device) from my patrol vehicle. I placed the terminator in front of the rear passenger tire and contacted the occupants from the passenger window. The vehicle was still off at this time. I told the male and female their vehicle and physical descriptions matched that of a residential burglary in the city this morning.

The male driver then quickly started the vehicle and reached for the gear shifter. I told the male to stop and that I placed a spike strip in front of his tire and that

if he drove off, he would have a flat tire. The male instantly had a defeated look grow on his face. I instructed male to turn the vehicle off and hand me the keys. The male did so. I had my firearm drawn (pointed at the ground) and instructed them to place their hands on the dash of the vehicle.

Officer Westman and Officer Rasmussen arrived on scene a short time later. The male and female were instructed to exit the vehicle. They were both detained in handcuffs without incident.

I ran the vin number on the Dodge Challenger, and it returned stolen out of Seattle PD as of 01/03/26. On the Challenger was CA rear plate #JTWAYUR which returned stolen out of Tacoma PD as of 01/05/26. Dispatch confirmed the stolen vehicle and stolen rear license plate.

The male suspect was identified as Michael J. Lemay (06/18/89). I verified his identity via his Washington State Department of Licensing photograph. Lemay returned with felony convictions for attempting to elude a police vehicle and theft 2.

The female suspect was identified as Haley A. Roy (11/12/98). I verified her identity via her Washington State Department of Licensing photograph. Roy returned with a misdemeanor warrant out of Lynnwood for reckless driving. In reviewing camera footage from the residential burglary, I was able to confirm that Lemay and Roy were the suspects that entered the garage and stole the Audi SUV. Lemay was wearing the same green sweatshirt and jeans that he was during the burglary. I noticed in the backseat of the vehicle was a red sweatshirt, it appeared to be the same sweatshirt that Roy was wearing during the burglary.

There were also white cat ears that Roy was wearing during the burglary attached to the passenger seat headrest. I read Lemay and Roy their Miranda warning at the scene, and they were taken into custody. Both agreed to provide a video and audio recorded statement and they were transported to the Snoqualmie PD.

Lemay's small dog was also inside the vehicle. The dog was taken to the Snoqualmie PD. The dog was later picked up by Lemay's friend Cory per his request.

At the Snoqualmie PD I interviewed Lemay first. It should be noted the computer software for the recorded room was not working properly so a department issued cell phone was used for audio and video recording. I read Lemay his Miranda warning again and Lemay stated I had permission to record the interview. Lemay said that a friend who was a mechanic let him borrow the Challenger. Lemay said his friend was working on the Challenger for a customer. Lemay

would not provide any other information on this "friend". Lemay said he had been in possession of the Challenger for 3 to 4 days. Lemay stated while in Snoqualmie this morning he stole 3-4 packages and committed 1 to 2 vehicle prowls. Lemay stated he entered the garage of a residence and stole items including "things" from the Audi SIV. When I asked Lemay if he stole a garage door opener to enter the garage, he said he thought so. Lemay admitted that after initially burglarizing the garage he and Roy returned, and Roy stole the Audi SUV. Lemay said the Audi was currently parked at Mt Si Sport and Fitness in North Bend. Lemay said the items they stole should still be in the Challenger.

I then interviewed Roy. I read Roy his Miranda warning again and Roy stated I had permission to record to the interview. Roy said that Lemay bought the Challenger from a friend and she and Lemay had been in it for about a week as they were both homeless. Roy said she and Lemay were friends. Lemay said early this morning in Snoqualmie, she and Lemay stole packages and prowled vehicles. Roy said she and Lemay entered the garage of the residence and stole items. She said they returned, and she stole the Audi and parked it in North Bend.

The Challenger was towed to the Snoqualmie PD secure sally port. Officer Westman completed a tow/impound form and followed the vehicle being towed to the Snoqualmie PD. Evidence tape was placed on the vehicle and it was photographed. A search warrant will be sought on the vehicle in the coming days.

The Audi was recovered at Mt Si Sport and Fitness in North Bend by Officer Westman. The keys for the Audi were located on Lemay upon search incident to arrest. Chase and Emily Wakefield (owners of the Audi) were contacted, and they retrieved their vehicle from Mt Si Sport and Fitness. For further facts and circumstances refer to Officer Westman's supplemental report.

I am referring charges on Lemay to the King County Prosecutor for:

Residential burglary – Lemay unlawfully entered the garage of 34426 SE Hearing St within the city limits of Snoqualmie and stole items.

Possession of a stolen vehicle – The white Dodge Challenger that Lemay was driving throughout 01/12/26 returned as a stolen vehicle out of Seattle. Lemay's story of how he acquired the vehicle was not believable. It is not reasonable for a mechanic to loan you a vehicle of a customers. It appears Lemay also tried to cover or conceal the vin number on the dash of the vehicle. There was a sticker or piece of paper that was similar color and font to the real vin next to the vin number. Suspects that driver stolen vehicles commonly try to cover this vin number in the dash to conceal it from Police.

Possession of stolen property x 2 – Lemay was in possession of the stolen Audi keys upon search incident to arrest. Lemay was also in possession of the stolen California license plate that was affixed to the rear of the vehicle. The license plate was confirmed stolen out of Tacoma.

Theft 3 – Lemay stated he stole several packages and items from vehicles. Specifically, Lemay and Roy stole groceries off the Porch of a residence at 9322 Frontier Ave SE within the city limits of Snoqualmie. . .

I am referring charges on Roy to the King County Prosecutor for:
